You may sign up to have your semi-annual property tax installments transferred electronically from your bank account to the Town. When you sign up for this program, we will debit your bank account for the exact amount of your semi-annual tax installment on the actual due date (September 10 and February 10) for each installment. If the due date falls on a weekend or holiday, we will debit your bank account on the next business day. You will still receive your bill in the mail. <u>Unless we receive written notification from you at least ten (10) days prior to the installment's due date, we will automatically debit your account for the amount of the bill on the due date.</u>

## This form must be **DELIVERED IN PERSON OR MAILED TO THE TREASURER'S OFFICE AT LEAST TEN (10) DAYS PRIOR TO THE SEMI-ANNUAL BILL DUE DATE OR IT WILL NOT BE IN EFFECT UNTIL THE FOLLOWING INSTALLMENT.**

You must attach a blank, voided check (for a checking account) or a blank, voided deposit slip (for a savings account) for the account you wish to have debited when you sign up for this program.

Please read the form carefully and bring (or mail) all the necessary information with you when you come to the Treasurer's Office to sign up.

I/we further agree that this direct debit authority will remain in effect indefinitely, unless and until I/we provide at least five (5) days' written notice of its cancellation to the Town of Westminster Treasurer's Office.
