- Front and rear mudflaps
- LED strobe and work lights
- Heated LED plow lights
- 4 rear hydraulic remotes to be plumbed with diverter valves for rake and sander operation
- Dual function electronic spreader control
- Stainless steel hydraulic lines where applicable
- 10' Steel reversible plow with adjustable attack angle, reversible push frame and plow shoes
- Truck to be outfitted with standard plow hoist and applicable cable activated hydraulics
