#### INTRODUCTION

The Town of Westminster requests sealed bids for the purchase of a new Front-End Loader to be used by the Town's Highway Department. Bids should be made to include both a bucket and fork attachment. As part of the overall bid, the Town would consider the option of trading in the current loader, a 2000 John Deere 544H model. The Town requests bids for a Front-End Loader comparable to a John Deere 544P, a Case 621G, a Komatsu WA270-8 or a Caterpillar 930.
