# Meeting of Westminster Selectboard November 25, 2014

Present: Paul Banik, Toby Young, Nate Stoddard, Craig Allen and Peter Barrett

Also Present: Russ Hodgkins, Mark Lund, Jan Ameen and Fran Renaud

- 1. The meeting was called to order by Chair, Nate Stoddard @ 7:00 PM.
- 2. Adjustments to the agenda: None
- 3. Acceptance of minutes from October 28, 2014: Craig moved to approve as corrected. Second by Toby. Passed unanimously.
- 4. Communication and Public Comment:

Andrew Cay of Intergrated Solar clarified intention of Kurn Hattin solar project for Whitney Blake.

The project is 1/3 the size of projects that recently went up in Westminster. The system is set now as a 150kw system and will eventually go to a 500kw system. It will be able to replace oil consumption at Kurn Hattin and take up to 44% power consumption.

Nate made comment of the moving of the project to a less desirable part of the property, away from hemlock grove where deer are wintering.

Peter asked what the life expectancy of the solar panels and parts? Andrew explained the life expectancy is over 25 years, it still can produce electricity.

Russ asked if the project could be seen from the road at all? Andrew said very little could be seen.

Jan Ameen: Stated she read in the Gazette that there would be 52 free bags given to residents a year for trash, and that greatly makes an inaccurate number she put together for all options offered. Could potentially show a \$190k loss in revenue.

It was found that it was not in the minutes or Gazette to state that fact.

Discussion followed.

Jan explained she had spoken to a number of businesses in town as well as Putney that are willing to sell bags if we go to the PAYT option.

She also suggested that Russ present options at the December 2, 2014 meeting, at this time Russ declined.

5. Unfinished Business: A. Draft of New Ordinance on Trails and Class 4 permits.

Russ explained that in paragraph 4, lines c and e should cover any question brought on by Toby in regards to permits needing to be issued for use of trails.

Toby will change wording in line c for stronger language and to be more specific on requirement and possibly ad an f line to the paragraph. Will forward to Russ.

- 6. New Business:
- A. Tad Montgomery would like to have a table and banner set up at the Dec. 2, 2014 meeting for information regarding Solarize Westminster.

Request denied by the selectboard unanimously.

B. Sign recommendations for Sand Hill Rd.

35 mph sign will be put in place along with Road closed sign for the winter. Mark will close the road from the Armory to the US Rt 5.

Motion made by Craig, second by Peter. Passed unanimously.

Nate asked Russ to inform Sandy Anderson of the decision.

Mark asked for closure of the Cemetery Hill Rd. through the winter along with a Jersey barrier? If there was a funeral the road could easily be opened up with a loader.

Motion made by Peter, second by Toby. Passed unanimously.

C. Complete Budget-1<sup>st</sup> draft. Discussion followed.

Motion made by Craig to go into executive session regarding appointment of a public figure and to discuss an employee request. Invited the Town Manager to join them. Second Peter, all in favor. Motion passed.

#### 7. Manager's Report:

Russ said Fletcher Proctor is on board to be at the Dec. 2 2014 meeting.

Options will need to be read at that time.

Jan Ameen asked if the vote at the Dec. 2cnd meeting could be amended at the Town Meeting in March?

Russ: Yes

Mike Mrowicki and David Deen would like to speak at the Dec. 23, 2014 selectboard meeting.

Russ explained that the town of Westminster was one of 6 towns chosen for an audit on the November 4 election by the Sec. of State's office. That we passed with no problems and Alison Bigwood should be commended for her actions.

Paul asked for a discussion about Open Meeting Law, doesn't want us to run into any issue's so please make agenda's clear. Also who prepares the agenda?

Russ will ask town council and have those answer's at the next meeting.

Correspondence was read by Russ regarding the appeal we won again on the Wilkinson property.

Letter was read from Norman Wright regarding Westminster West Cemetery. That will be on the agenda for the December 9, 2014 meeting.

Reed Webster on the Town Crew is retiring, his last day is November 30, 2014.

#### 8. Boards and Commissions:

Russ brought to attention the new budget line concerning the Planning Commission to cover Town Plan and Bylaws for legal council to view.

The next selectboard meeting is December 9, 2014.

No other business to come before the board, meeting adjourned to go into executive session @ 8:56 PM.

- 2.) Adjustments to the agenda: None
- 3.) Acceptance of minutes from the November 25, 2014 meeting. Motion made by Toby, seconded by Peter. Passed unanimously.

Russ gave copies of a letter from Bruce Murray to the selectboard.

- 5.) Unfinished Business:
- A) Selectboard decision on trash. Motion made by Toby to accept the vote at the Dec. 2, 2014 meeting for Option 1(no trash pickup), seconded by Peter.

#### Discussion:

Russ met with Chip Sterns to talk about Westminster's participation at the Rockingham Transfer Station. Facts concerning permits, recycling, volume and time of operation. Rockingham will not restrict Westminster resident's participation, because of this Rockingham is assuming that the same tax deal will apply.

Budget line to be put in FY16 for the road crew to remove trash along the roads because of the "no trash option". The budget is for disposal of the trash only, road crew would do this on their normal salary.

Motion passed unanimously.

- B) Motion made by Craig to buy back 4 lots at the Westminster West Cemetery as recommended by our Cemetery Sexton, Norm Wright, because we are running out of room at this location, at a price not to exceed \$260.00 total. Seconded by Peter, passed unanimously.
- C) Draft 2 complete expenditure and revenue budget reports.
   Russ requested any revisions be brought to his attention next week.
